

VIP Holiday Giveaway

Official Rules

Introduction

The VIP Holiday Giveaway (“Sweepstakes”) is sponsored by Florida Panthers Hockey Club, Ltd. (“Sponsor”).

Eligibility

The Sweepstakes is open to all legal residents of the state of Florida who are at least 18 years old. Employees and officers of Sponsor and Sponsor’s parent companies, subsidiaries, affiliates and related entities, advertising agencies, authorized dealers, promotional suppliers, prize providers (each of the aforementioned entities and/or persons collectively, with Sponsor, the “Sweepstakes Entities”) and the immediate family members (spouses, parents, children and siblings and their spouses) or members of the same household (whether related or not) of such individuals are not eligible to enter or win.

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

Sweepstakes Period

The Sweepstakes commences on November 21, 2022 (“Start Date”) and ends on December 30, 2022 (“End Date”). The period commencing on the Start Date and ending on the End Date is hereinafter known as the “Sweepstakes Period”.

Method of Entry

Each eligible entrant is limited to one (1) entry during each Prize Period (defined below) and may enter only by:

1. Submitting the entry form (https://tradablebits.com/tb_app/479853) to be distributed by Sponsor on Sponsor’s official social media accounts during a Prize Period; or
2. Mailing a 4” x 6” card to Florida Panthers Marketing Department, FLA Live Arena, 1 Panther Parkway, Sunrise, FL, 33323 with the following information:
 - a. First and last name
 - b. E-mail address
 - c. Phone number
 - d. Date of birth
 - e. The following statement: “Please accept this card as entry into the VIP Holiday Giveaway.”

If an eligible entrant elects to enter via mail as described above, he or she will be deemed to have entered the Sweepstakes during the Prize Period in which Sponsor receives his or her entry via mail.

The deadline to enter the Sweepstakes in any Prize Period is on the final day of the applicable Prize Period at 11:59PM Eastern Standard Time (“EST”), and no entries will be accepted after such time.

Prize and Odds

Sponsor will select one (1) winner (each a “Winner”) from a random drawing of all eligible entries received during each week of the Sweepstakes Period identified below (each a “Prize Period”) to win two (2) club-level tickets to the applicable Event to take place at the sports and entertainment facility located at 1 Panther Parkway, Sunrise, Florida 33323 and known as “FLA Live Arena” on the Event Date identified below (each such pair of tickets is a “Prize”, and all such pairs of tickets, collectively, are the “Prizes”).

The fair market value (“FMV”) of all Prizes combined is **\$1,604.00 USD**. Odds of winning each Prize depend on the total number of eligible entries received during each Prize Period.

Prizes will only be awarded and delivered to addresses within the State of Florida. Except as determined by the Sponsor in its sole discretion, no substitution of any Prize is offered, no transfer of any Prize to a third party is permitted, and no Prize may be redeemed for cash value. Winner shall be responsible for all food and beverage, transportation, parking, and/or other ancillary costs associated with the Prize he/she wins, and use of such Prize by him/her shall at all times be subject to all applicable Sponsor and FLA Live Arena regulations and policies, as any exist now, may be amended from time to time or may arise hereafter, and all applicable laws. Any portion of the Prize not accepted by the Winner will be awarded to an alternate winner in accordance with the section entitled “Winner Selection and Notification” below. In no event will Sponsor be liable to award more than the number of Prizes stated in these Official Rules.

Winner Selection and Notification

Each Winner shall be announced on or about the day following the conclusion of the applicable Prize Period. Winner will be notified that he/she is the Winner for the applicable Prize Period via e-mail and/or phone number at the e-mail address or phone number supplied on entry. Each

entrant is responsible for monitoring his/her e-mail and phone for such notification, instructions to claim the applicable Prize, and any other communications related to this Sweepstakes. If any Winner cannot be reached by the Sponsor within two (2) days or if any Prize is returned as undeliverable, the applicable Winner shall forfeit the applicable Prize and such Prize will be awarded to an alternate winner. Upon the request of the Sponsor, Winner (or, if applicable, alternate winner) may be required to return an Affidavit of Eligibility, Release and Prize Acceptance Form, IRS W-9 form, a liability release, and (where legal) a publicity release, all of which must be returned within the time period specified within such materials. Should any Winner (or, if applicable, alternate winner) fail to comply with any such requirements, the applicable Winner (or, if applicable, alternate winner) may be disqualified by Sponsor, in Sponsor's sole discretion, and Sponsor may then select an (or, if applicable, another) alternate winner.

Acceptable Conduct

By entering this Sweepstakes, entrants agree to be bound by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. Failure to comply with these Official Rules may result in disqualification. Sponsor reserve the right at its sole discretion to disqualify any individual suspected of tampering with the entry process or the operation of the Sweepstakes; or to be acting in any manner deemed by Sponsor to be in violation of the Official Rules; or to be acting in any manner deemed by Sponsor to be unsportsmanlike or disruptive, or with intent to annoy, abuse, threaten or harass any other person. CAUTION: ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVE THE RIGHT TO SEEK DAMAGES AND COSTS (INCLUDING WITHOUT LIMITATION, ATTORNEYS' FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

Limitations of Liability

The Sponsor assumes no responsibility or liability for (a) any incorrect or inaccurate registration or entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (b) any unauthorized access to, or theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (c) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (d) inaccessibility or unavailability of the Internet, the Application (if applicable), or any combination thereof; or (e) any injury or damage to any participant's or to any other person's computer or cell phone which may be related to or resulting from any attempt to participate in the Sweepstakes or download any materials in the Sweepstakes. If, for any reason, the Sweepstakes is not capable of running as planned for reasons which may include without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper conduct of this

Sweepstakes, then Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes in whole or in part. In the event of cancellation, a random drawing will be conducted to award the Prizes from all eligible entries received prior to cancellation.

Releases

All entrants, as a condition of entry into the Sweepstakes, agree to release the Sweepstakes Entities from and against any and all liability, claims or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained in connection with: accessing the internet; submitting an entry or otherwise participating in any aspect of the Sweepstakes; the receipt, ownership or use of a Prize awarded; preparing for, participating in, attending or traveling to and/or from any Prize-related activity; or any typographical or other error in these Official Rules or the announcement or offering of a Prize awarded. Winner shall bear all risk of loss or damage to the applicable Prize after it has been delivered. The Sponsor makes no representations or warranties of any kind concerning the appearance, quality, safety or performance of any of the Prizes.

By accepting the applicable Prize, the Winner agrees for him or herself and for each of his or her heirs, executors and administrators to release, indemnify and hold harmless the Sweepstakes Entities and their respective successors, owners, general and limited partners, shareholders, members, directors, officers, employees, agents and representatives from and against any and all liability for any loss, harm, damages, costs or expenses, including without limitation property damages, personal injury and/or death, arising out of (i) participating in this Sweepstakes, (ii) the acceptance, possession, use or misuse of the applicable Prize, (iii) preparing for, participating in and/or traveling to or from any applicable Prize-related activity, (iv) claims based on rights of publicity, rights of privacy, defamation, or (v) applicable Prize delivery.

Use of Information

Personally identifiable information that is submitted by entrants as part of this Sweepstakes will be solely used to administer the Sweepstakes, select each Winner, and fulfill the Prizes, unless the entrant actively opts in to receive marketing communications.

Interpretation/Choice of Law

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sweepstakes Entities in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Florida, without giving effect to any choice of law or conflict of law rules. Any and all disputes, claims and causes of action arising out of or in connection with this Sweepstakes or any Prize awarded shall be resolved exclusively in the appropriate federal or state court located in Broward County, Florida, and entrants hereby consent and submit to the personal jurisdiction of such courts.
